### MINUTES

Mr. Bobinas made a motion to approve the March 2018 minutes. Mr. Angelo seconded the motion. The motion passed as presented.

### **FINANCIAL REPORT**

Mr. Angelo made a motion to approve the March Financial Report. On the question, Mr. Bobinas questioned why billing is split within the borough. Mr. Mahalchick will find out. Mapping will be done and the budget for the project updated.

Ray Sukeena reported a request to lower the two manholes on the High School Baseball Field. Don Cuff stated the manholes are already in the GPS system. It is not the Authority's responsibility or expense to lower the manholes. Ray Sukeena stated that he is working on a schedule for cleaning the storm drops. Mr. Bobinas stated that after the original cleaning it should not be as bad. Mr. Eltringham instructed the cleanings to go on Mr. Sukeena's monthly reports.

The Solicitor was not present at the April meeting.
