A general meeting of the Sewer Authority of the Borough of Minersville was held Wednesday, May 22, 2019 in Council Chambers, North Delaware Avenue and East Carbon Street. Chairman Thomas Eltringham opened the meeting with the flag ceremony at 7:00PM.

ATTENDANCE

The following members attended the May meeting- Jeremy Olenick, Santino Angelo, Thomas Eltringham, Al Bobinas, Councilman Steven Darosh, Ray Sukeena, Sewer Plant Manager and Borough Manager, Robert Mahalchick.

MINUTES

Mr. Angelo made a motion to approve the April 2019 minutes. Mr. Olenick seconded the motion. The motion passed as presented

VISITORS

There were no visitors present at the May meeting.

FINANCIAL REPORT

Mr. Angelo made a motion to approve the April Financial Report. Mr. Bobinas seconded the motion. The motion passed as presented.

ENGINEER'S REPORT

Mr. Cuff was not present at the May meeting.

SEWER OPERATOR'S REPORT

Mr. Sukeena presented members with a written report. Mr. Sukeena reported that the press pumps were pulled out to get rebuilt and he was told they are beyond repair. There are a total of four pumps. Mr. Olenick questioned the status of the other two pumps. He suggested that during the time we are waiting for two new pumps to be ordered and installed, the other two pumps be sent for any needed repairs. Mr. Angelo made a motion to authorize the purchase of two new pumps at a cost of \$5400 each. Mr. Bobinas seconded the motion. The motion passed as presented. Mr. Olenick made a motion, second by Mr. Angelo to send the remaining two pumps out to be rebuilt. The motion passed as presented.

Mr. Sukeena presented a written report on the inlet inspections. Mr. Eltringham questioned the number of inlets. Mr. Sukeena stated that there are 476. Mr. Sukeena stated that he is hoping to have all of them done by the end of summer. He stated that he and Mr. Carvajal are fine doing the inspections themselves. The Borough workers can help with routine cleaning once the initial inspections are complete. Mr. Sukeena stated that when there are a dozen inlets that need heavy cleaning, he would call a company in to clean them. Mr. Sukeena will work with the Water Authority and the Borough to work on repairs while other street work is being done. Mr. Mahalchick will keep Mr. Sukeena informed of the streets being paved. Mr. Sukeena will order new grates and frames for inlets as needed. Mr. Sukeena stated that the down spouts at the Quandel project have been inspected and are separated.

Mr. Darosh reported that the drain on the 500 block of Lytle Street needs repairs.

There was no Unfinished Business to discuss.

NEW BUSINESS

There was no New Business to discuss.

Mr. Mahalchick suggested that members visit the Sewage Treatment Plant during working hours.
