ATTENDANCE

MINUTES

Mr. Olenick made a motion to approve the August 2018 minutes. Mr. Angelo seconded the motion. The motion passed as presented.

FINANCIAL REPORT

ENGINEER'S REPORT

Don Cuff reported that Sewer Specialties was delayed but should be in the Borough next week. The impact of the summer storms will add an additional week to their original work order, increasing the price an additional \$10,000. This cleaning needs to be done immediately.

Don Cuff reported that the Borough Council has instructed Street Workers to assist in identifying drainage areas.

SEWER OPERATOR'S REPORT

Ray Sukeena presented a written report. Mr. Sukeena reported that the grit collector is up and running.

Mr. Sukeena reported that National Soil Products requested the plant take their wastewater. After consulting with Don Cuff, it was decided to deny the request due to the amount of ammonia in their water.

Mr. Sukeena reported that there was a sewage backup at Myrtle May's Restaurant. The owner called Roto Rooter, who thought the damage was in the street. Workers originally agreed the blockage was in the street, but after working they found damage to the pipe in the parking lot, thus it is the owners' expense. Mr. Eltringham suggested looking up the permit for the owner having the lot surfaced. Mr. Sukeena feels the owner will want reimbursement for Roto Rooter as well as his lot repaired. Mr. Bobinas suggested sending a bill for our services, perhaps at half the cost, to show our good faith. Mr. Eltringham suggested Mr. Sukeena have Mr. Mahalchick contact Myrtle May's owner.
