### CORRESPONDENCE

Mr. Nick Todak, 425 St. Francis Street, requested reimbursement of \$55.50 he paid to Hadesty's to unblock sewer line. It was determined the blockage was in the street. Mr. Bobinas made a motion to approve the request, Mr. Olenick seconded the motion. The motion passed as presented.

## **NEW BUSINESS**

Mr. Sukeena submitted a request to purchase an icemaker for the composite samplers. Currently it costs \$6.50 to buy a bag of ice and we use 30 to 40 pounds of ice per week. The Water Company has similar samplers and is willing to split the cost of an icemaker. Mr. Sukeena estimates the cost would be \$300, or \$150 for each entity. Mr. DiBiase made a motion to approve the purchase, Mr. Olenick seconded the motion. The motion passed as presented.

Mr. Mahalchick requested permission to purchase a wet saw for use on asphalt cutting, which the employees have to do. Mr. Mahalchick explained his concern for employees inhaling the silica dust and the future health consequences that may have, Mr. DiBiase made a motion to approve the purchase of a wet saw with a cost limit of \$2000, Mr. Bobinas seconded the motion. The motion passed as presented. Mr. Mahalchick will approach Council to split the cost.

Mr. Mahalchick distributed the 2017 Sewer Authority Audit. Mr. Bobinas made a motion to approve the audit, Mr. DiBiase seconded the motion. The motion passed as presented.

Mr. DiBiase made a motion to adjourn. Mr. Bobinas seconded the motion.
