MINUTES

Mr. Bobinas made a motion to approve the minutes from the May 2022 meeting. Mr. DiBiase seconded the motion. The motion passed as presented

FINANCIAL REPORT

Mr. Enders made a motion to approve the April Financial Report. Mr. DiBiase seconded the motion. The motion passed as presented.

Mr. Olenick made a motion to approve the May Financial Report. Mr. Enders seconded the motion. The motion passed as presented.

ENGINEER'S REPORT

Mr. Bobinas made a motion to approve Requisition #29 in the amount of \$306,857.38, which represents payments to Entech in the amount of \$12,963.93; Payment of Application #8 and #9 to Pat Aungst, Inc. for the Sunbury Street Storm Project; Wind River Environmental in the amount of \$38,063.63 and Strouse Brothers in the amount of \$1,050.00. Mr. DiBiase seconded the motion. The motion passed as presented.

Mr. DiBiase made a motion to approve payment of Application #8 and 9 to Aungst in the amounts of \$116,914.50 and \$57,976.76 respectively, for the Sunbury Street Project. Mr. Bobinas seconded the motion. The motion passed as presented.

Mr. DiBiase made a motion to approve Change Order #4 to Aungst for the Sunbury Street Project in the amount of \$112,00527. Mr. Enders seconded the motion. The motion passed as presented.

SEWER OPERATOR'S REPORT

Mr. Sukeena presented members with a written report. Mr. Sukeena reported that our camera has died. He is waiting for quotes. But prices range from approximately \$6500 to \$11,000. Mr. Sukeena reported that currently Frackville is televising for us. Mr. Enders suggested the type camera Shamokin uses, which can record and do voice over. Mr. Bobinas asked if communities share items. Mr. Sukeena replied that we di share with Schuylkill Haven and Frackville.

UNFINISHED BUSINESS

Mr. Sukeena reported that Wynosky has not been back to finish the Bowers Project. When contacted, he plans to finish this week.

OLD BUSINESS

Mr. Sukeena reported Pioneer has not been to the plant to check out the termite damage at the back of the plant and give a quote. Mr. Bobinas suggested contacting the vo-tech to question if they would be willing to do the project.
