Mr. DiBiase made a motion, second by Mr. Olenick to approve payment of Requisition #33 in the amount of \$322,894.07 which includes payment to Entech in the amount nt of \$27,773.75 and Barrasso Excavation for Application #4 for the Pine Street project in the amount of \$295,120.32. The motion passed as presented.

Mr. Bobinas made a motion, second by Mr. DiBiase to approve Payment #4 to Barrasso, which is included in the above Requisition #33, in the amount of \$295,120.32. The motion passed as presented.

Mr. DiBiase made a motion to approve Change Order #1 to Entech for the Pine Street Project for the rain leaders and ADA Ramps in the amount of \$150,616.25. On the question, Mr. Bobinas asked if Penn Dot was responsible for the ramps. Mr. Cuff responded that it is not a state road and the ramps are ADA not Penn Dot compliant. Mr. Enders seconded the motion, the motion passed as presented.

Ray Sukeena was not present at the October meeting, but presented a written report to Authority members.
