# **SEWER OPERATOR'S REPORT**

Ray Sukeena presented members with a written report. Mr. Sukeena reported 180 feet of sewer line had been unearthed during the Water Company's project on North Street. The line is half full of sludge and USP will be clearing out the pipe.

Mr. Sukeena reported Blooming Glen had again tried to replace the grates and failed. Mr. Sukeena stated Blooming Glen is looking to by-pass the pumping, which will have to be reported to DEP. Blooming Glen estimates by working in 24-hour shift, it will take two days.

Mr. Sukeena reported the Sewer Authority's truck, a 2004 model, cannot be inspected again. Mr. Sukeena will compare prices with Co-stars on a new model and also used models from both Jerry Enders and Chris Swolinsky. Mr. Mahalchick suggested a club cab model would allow the supplies to be put in the back seat area.
